## Creating Mailing Labels via Real Property Search

These instructions are for desktop web browser versions, but mobile devices can be used. Mobile device may look different from example screenshots used in this document.

**Step 1:** Navigate to the Martin County Property Appraiser's website ([www.pa.martin.fl.us](http://www.pa.martin.fl.us)):

**Step 2:** On the homepage you will see a Real Property Search window. Simply search using name, address, parcel ID number, account number, or subdivision name.

**Step 3:** When the results page appears, you will see a button above the results called “Export to Labels (PDF)”. By clicking this button, a print window will open, and you will want to select PDF as the printer. The PDF document will display the owner names and mailing addresses for all selected records in standard Avery 5160 format.

**Tip:** The Export List to Labels (.PDF) tool is also available on the Business Search ([Business Search Link](#)) and the Sale Search ([Sale Search Link](#)).

**Example of Results:** The first page of the pdf is a notice about the data included in the pdf document and explains that certain owners who qualify for public records exemptions under F.S. 119.071 & 493.6122 will not be available.
